You will explore the role of marketing strategy in shaping organisational objectives of globally oriented firms and contemporary issues such as the impact of social media and digital channels. As you move through the programme you will learn to synthesise and apply the relevant marketing concepts and frameworks to practice and show how they can be used to support strategic decision-making.</p>

As you move through the course you will become capable of speaking in an impromptu manner, answering questions concisely, delivering as a professional and credible speaker. Collaboration, networking, building rapport, and influence are important aspects of the ways you engage with others in business as are supporting and encouraging others. As you will often work collaboratively in a team, you will need to formulate ideas and opinions with precision, relating your contribution skillfully to speakers from diverse backgrounds. Managers effect change through personal influence, and this often requires working in and through networks. Your advanced work will encourage you to be proactive in building a network to access and employ resources that you do not own.
